

YOUR PRIVACY

How we collect and use your personal information

Agentic Fire and Safety Pty Ltd respects your privacy and is committed to protecting your personal information.

The Privacy Act requires us to tell you when we collect personal information and how we will use it. Personal information is information about you, such as your name and address (not information about the organisation for which you work). We generally collect and use the personal information we need to provide and market our services, complete business transactions, provide customer support and purchase products and services from you and the organisation for which you work.

We have recorded your details so we can contact you in future. We may use your information to send you our publications, invite you to business functions or activities and inform you of any new or upcoming products and services. Sharing your information

Agentic Fire and Safety Pty Ltd may share personal information with other companies trading under Agentic Fire and Safety Pty Ltd's affiliates and related bodies corporate. - (b) Government authorities.

Some of these organisations may be overseas. You can access most personal information that Agentic Fire and Safety Pty Ltd holds about you. Sometimes that will not be possible, but if that is the case you will be told why. A fee may apply.
